For 2013, consolidated revenue is €200.0m. At constant exchange rates, structure and accounting method, this represents a 5.2% decrease compared to 2012.

Current operating income represents €7.2m. The decline in revenue impacts the current operating income and explains most of the variation. Operating income amounts to €3.3m and includes restructuring costs in France for €1.9m, losses of Switzerland for €1.0m and the negative impact of the termination of FBC Software for €1.1m.

Net result includes a financial result of \in -4.4 million (including \in -1.6m of exchange rate impact), taxes of \in -3.3 million as well as the effects of Germany for \in -2.8 million.

Bank covenants continue to be respected.

Patrick Bensabat, CEO of Business & Decision, said: "The restructuring efforts helped to adjust the structure of operational costs and eliminate unprofitable activities. We conducted, for 3 years, an action plan to improve the performance and the repositioning at the Group level. The end of 2013 marks the completion of the plan at all levels of the organization of the Group."

Outlook

The Group continues its major future investments in Big Data, in the Cloud Computing and in accompanying clients in their digital transformation. Development prospects associated with higher levels of profitability allow to positively consider the year 2014.
