# STRONG INCREASE OF OPERATING INCOME FOR THE FIRST HALF OF 2014

Paris, August 27th 2014,

Business & Decision, a global information services Group, announces for the first half of 2014 (period 1 January to 30 June 2014), an operating income of €3.8m at 3.9% of total revenue. This represents a strong increase in comparison to the first half of 2013 and marks the Group's performance for the period.

Patrick Bensabat, CEO of Business & Decision, comments: "The first half of 2014 has benefited fully from the actions undertaken to return to profitability, conducted for more than two years. Our performance ratios are now at discounted levels and our profitability restored."

For the first half of 2014, net sales amounted to €98.4m, an increase of 0.24% compared to the first half of 2013 at constant structure and exchange rates.

&Net income amounted to €1.5m, compared to a loss of €1.7m in the first half of 2013. The return to profitability is mainly due to the absence of exceptional items that heavily impacted 2013 first half and full year.

## Outlook

Perspectives for development and growth for the coming months are particularly favorable in the light of the directions taken in terms of offerings and positioning. The BI market is expected to experience a revival thanks to Big Data. The market for digital services should benefit, in the field of CRM, from increased business demand.
