It enables companies to digitally manage their video and metadata easily and conveniently, before efficiently delivering the content to internet or VOD platforms.

TELE 5 will use Fluid MAM to deliver more than 1,200 hours of VOD content annually. The flexible playoutsystem Fluid PLAY guarantees high audiovisual quality and allows for sophisticated video effects and special forms of advertising.
