Terms used herein shall be deemed to be defined as such for the purposes of the terms and conditions (the "**Conditions**") set forth in the base prospectus dated 26 November 2015 which received visa no. 15-610 from the *Autorité des marchés financiers* (the "**AMF**") on 26 November 2015 as supplemented by its supplement no. 1 dated 11 January 2016 which received visa no. 16-019 from the AMF on 11 January 2016, its supplement no. 2 dated 21 March 2016 which received visa no. 16-087 from the AMF on 21 March 2016 and its supplement no. 3 dated 8 November 2016 which received visa no. 16-521 from the AMF on 8 November 2016, which together constitute a base prospectus (the "**Base Prospectus**") for the purposes of the Directive 2003/71/EC of the European Parliament and of the Council of 4 November 2003, as amended (the "**Prospectus Directive**").

This document constitutes the final terms of the Covered Bonds (the "**Final Terms**") described herein for the purposes of Article 5.4 of the Prospectus Directive and must be read in conjunction with such Base Prospectus as so supplemented. Full information on the Issuer and the Covered Bonds is only available on the basis of the combination of these Final Terms and the Base Prospectus as so supplemented. The Base Prospectus, the supplement to the Base Prospectus and these Final Terms are available for viewing on the websites of Crédit Agricole S.A.
