("MSBV") and Morgan Stanley Finance LLC ("MSFL") have prepared this fourth supplement to the registration document (the "Fourth Registration Document Supplement") to supplement and be read in conjunction with the registration document dated 9 June 2017 (the "Registration Document") as supplemented by the first supplement to the Registration Document dated 25 August 2017 (the "First Registration Document Supplement"), the second registration document supplement dated 18 October 2017 (the "Second Registration Document Supplement") and the third registration document supplement dated 28 November 2017 (the "Third Registration Document Supplement") of Morgan Stanley, MSI plc, MSBV and MSFL.

# Status of Supplement

This Fourth Registration Document Supplement has been approved by the Luxembourg Commission de Surveillance du Secteur Financier (the "CSSF") which is the Luxembourg competent authority for the purpose of Directive 2003/71/EC, as amended (the "Prospectus Directive") and relevant implementing measures in Luxembourg as a registration document supplement prepared in compliance with Article 16.1 of the Prospectus Directive and relevant implementing measures in Luxembourg.

Unless otherwise defined in this Fourth Registration Document Supplement, terms defined in the Registration Document shall (as supplemented by the First Registration Document Supplement, the Second Registration Document Supplement and the Third Registration Document Supplement) have the same meaning when used in this Fourth Registration Document Supplement. To the extent that there is any inconsistency between any statement in, or incorporated by reference in, this Fourth Registration Document Supplement and any other statement in, or incorporated by reference in, the Registration Document (as supplemented by the First Registration Document Supplement, the Second Registration Document Supplement and the Third Registration Document Supplement), the statements in this Fourth Registration Document Supplement will prevail.

This Fourth Registration Document Supplement constitutes a supplement to and should be read in conjunction with, the Registration Document (as supplemented by the First Registration Document Supplement, the Second Registration Document Supplement and the Third Registration Document Supplement).

#### Information being supplemented

The purpose of this Fourth Registration Document Supplement is to:

(a) disclose the publication by Morgan Stanley of its Annual Report on Form 10-K for the year ended 31 December 2017 (the "Morgan Stanley 2017 10-K") and incorporate by reference certain sections of the Morgan Stanley 2017 10-K as set out in "Part A" of this Fourth Registration Document Supplement; and

# PART B CONSEQUENTIAL AMENDMENTS TO THE REGISTRATION DOCUMENT

The Registration Document is hereby amended as follows:

- 1. - 2. The paragraph immediately before the section entitled "Additional Information" on page 60 of the Registration Document shall be deemed deleted in its entirety and replaced by the following:

"Save as disclosed in:

- (a) the section entitled "Legal Proceedings" in Part I Item 3 at pages 23-28 and in the paragraphs beginning with "Legal" under the heading "Contingencies" under the heading "Commitments, Guarantees and Contingencies" in "Notes to Consolidated Financial Statements" in Part II Item 8 at pages 145-148 of Morgan Stanley's Annual Report on Form 10-K for the year ended 31 December 2017; and
- (b) in this section "Legal Proceedings and Contingencies" of the Registration Document,

there are no, nor have there been, any governmental, legal or arbitration proceedings involving Morgan Stanley (including any such proceedings which are pending or threatened of which Morgan Stanley is aware) during the 12-month period before the date of this Registration Document which may have, or have had in the recent past, a significant effect on the financial position or profitability of Morgan Stanley or the Morgan Stanley Group."

- 3. On page 61 of the Registration Document, the final paragraph under the heading "Trend Information" shall be deemed to be deleted in its entirety and replaced by the following:
  - "There has been no material adverse change in the prospects of Morgan Stanley since 31 December 2017."
- 4. On page 61 of the Registration Document, the paragraph under the heading "Significant Change" shall be deemed to be deleted in its entirety and replaced by the following:
  - "There has been no significant change in the financial or trading position of Morgan Stanley since 31 December 2017."
- 5. The section entitled "Selected Financial Information of Morgan Stanley" on page 68 of the Registration Document shall be deemed to be deleted in its entirety and replaced by the following:

"The remainder of this section contains selected financial information of Morgan Stanley relating to the years ended 31 December 2016 and 31 December 2017. The information set out below is derived from the audited financial statements included in Morgan Stanley's Annual Report on Form 10-K for the year ended 31 December 2017.
