### 6. Performance of Index and Other Information concerning the Underlying Reference

The Notes have a tenor of 10 years. The Final Redemption Amount of the Notes is linked to the performance of the Stoxx Global Low Carbon Select 100 Index (as at the date hereof, Bloomberg: SXW1CSEE Index) as specified under Part A, with a minimum of EUR 1,000 per Calculation Amount.

The STOXX Global Low Carbon Select 100 Index captures the performance of low carbon emissions stocks with low volatility and high dividends from the Stoxx Global 1800 Index. The component selection process first excludes all stocks that belong to the ICB Subsector 1771 (Coal), then selects in each ICB industry all stocks whose Carbon Intensity is the lowest. Next, it excludes all stocks whose 3- or 12-month historical volatilities are the highest. Among the remaining stocks, the 100 stocks with the highest 12-month historical dividend yields are selected to be included in the index. The percentage of exclusion/inclusion at each step is the same. The indices are reviewed quarterly..
