### Financial indicators in Strong growth

The financial report for the year 2021 confirms the turnaround taken by the Intrasense Group, which is accelerating its growth momentum, with record revenues and a positive evolution of its gross margin.

Fueled by a capital increase, successfully completed in June 2021, and supported by an ambitious growth plan, the Group's commercial dynamism is strengthening on its key markets, Europe and China.

These good results confirm the strategic relevance of the Group's investments. They also demonstrate the success of Intrasense's industrial and commercial expansion policy, based on innovation and the strengthening of its sales teams. The outlook is promising in the fast-growing radiology and oncology markets, notably thanks to new partnerships and the development of the new Myra product line.

- Revenues up by +22% compared to 2020
- Gross profit was up by +21%
- Cash position strengthened to nearly €4.8 million
- Continued strategic investments to accelerate growth in 2022
