

A Strong Growth

AKKA Technologies Group generated revenues of **282.8 M€ over the first 9 months.** The activity is good with **a sustained organic growth** and **an international business still dynamic, up 47%.**

Q3 sales are up 75% to 87.9 M€ compared to 2007, of which 13% is due to organic growth. At 30 September, consolidated revenue was 282.8 M€, up 87%.

Over 9 months, performance indicators are trending upwards and excluding **COFRAMI**, **revenue rose** by 22% of 184.4 M€.

Outside France, sales grew 47% to 29.2 M€, with all our subsidiaries posting dynamic performances.

Over the period, the Group was able to strengthen its positions across all business segments while demand for services remained strong amid an international economic environment in turmoil.

2008 Targets confirmed

The Group is continuing on its road map and confirming the targets announced for the full fiscal year:

- Revenue is expected to top 380 M€.
- Growth, excluding Coframi, will exceed 13%.
- Current operating income ratio is expected to come close to that achieved in the first half of 2008.
