Fady Khallouf appointed CEO of THEOLIA

He has previously held the position of CEO of Tecnimont where he led the industrial and financial restructuring of the group. Prior to that, he took part in the restructuring of Edison, transforming the holding company into an operational company, improving the group's profitability and assuring the monitoring of its investments. Fady Khallouf had beforehand held various management positions, notably specialized in the fields of investments and business development, at EDF, Suez, SITA/ Novergie and Lyonnaise des Eaux-Dumez.
