## ARCHOS

## Press release for regulated information

Mr. Henri Crohas, CEO of Archos, and DISH Network Corporation (formerly known as Echostar Communications Corporation) wish to inform the public that, by mutual agreement, they decided to terminate their concerted action regarding Archos (Notice No. 210C0459 available on AMF web site www.amf-france.org).

Therefore, they terminated on May 21, 2010 the shareholders' agreement which they had entered into on April 7, 2005. In addition, by virtue of a letter sent to Mr. Crohas also dated May 21, 2010, the preferred share held by DISH Network Corporation was converted into a common share. As a result, the preferred share will be withdrawn from the articles of association of Archos at the next general meeting of shareholders called for June 4, 2010.

Their respective individual positions remain unchanged: Mr. Crohas holds 3.318.584 shares, which represents 16.87 per cent of Archos' share capital and voting rights and DISH Network Corporation holds 1.398.619 shares, which represents 7.11 per cent of Archos' share capital and voting rights, as well as 553.040 convertible bonds. Dish Network Corporation is no longer represented at the Board of Archos since June 23, 2009

Mr. Crohas agreed to grant to DISH Network Corporation a proportional tag along right, similar to the one entered into in 2008 with Echostar Corporation, its sister company (Notice No. 2090039 available on AMF web site www.amf-france.org). This new agreement will terminate upon the full redemption of the convertible bonds still held by EchoStar Corporation, and at the latest on April 7, 2015.
