FIGEAC AÉRO STRENGTHENS ITS CSR STRATEGY BY APPOINTING FRANCK PORIER AS HEAD OF CSR

"Surface treatment is an activity that ties in closely with R&D, innovation and the REACH regulation, for instance, so I was already very much in tune with CSR issues", notes Franck Porier. "I therefore see my new duties as being a perfectly natural progression. I will do my utmost to take an active part in being attentive to our stakeholders, raising awareness of environmental matters among all our staff members and, more generally, beefing up our societal engagement, notably under Europe's CSRD."

This development is a reflection of FIGEAC AÉRO's determination to give CSR issues a central role in the Group's development model, which is geared towards creating substantial value for all stakeholders by combining long-term vision, profitable growth and sustainable approach. As a key player in the aerospace supply chain, the Group is set to fully play its role, in partnership with its clients and suppliers, in the advent of zero-carbon aviation.
