

## FDE holds now 3.31% of its own shares through its share buyback program

**Pontpierre, France, July 11<sup>th</sup>, 2024** - FDE (Euronext: FDE - ISIN: FR0013030152), a carbon negative energy producer, announces that it has bought back during the period of 1<sup>st</sup> July to 5<sup>th</sup> July 2024, 18,681 of its shares.

As FDE is currently in a negative period window, it will resume the share buyback program at the end of July, in accordance with the delegation of authority adopted by the Annual General Meeting of Shareholders of November 30<sup>th</sup>, 2023.
