

## FDE buys back some of its share issued capital via its buy-back program

**Pontpierre, France, August 27<sup>th</sup>, 2024** - FDE (Euronext: FDE - ISIN: FR0013030152), a carbon negative energy producer, announces that it has bought back during the period of 19<sup>th</sup> August to 23<sup>rd</sup> August, 4 856 of its shares.

FDE continues the implementation of the share buyback program following the delegation of authority adopted by the Annual General Meeting of Shareholders of November 30<sup>th</sup>, 2023.
