

## FDE buys back some of its share issued capital via its buy-back program

**Pontpierre, France, September 10<sup>th</sup>, 2024** - FDE (Euronext: FDE - ISIN: FR0013030152), a carbon negative energy producer, announces that it has bought back during the period of September 2<sup>nd</sup> to September 6<sup>th</sup>, 3 075 of its shares.

FDE continues the implementation of the share buyback program following the delegation of authority adopted by the Annual General Meeting of Shareholders of November 30<sup>th</sup>, 2023.
