## **Aéroports de Paris**

### **2009 airport fees tariffs**

As part of the 2006-2010 Economic Regulation Agreement (ERA) signed with the French government:

- Aéroports de Paris presented a proposal to the Economic Advisory Committee of the Paris-Charles de Gaulle and Paris-Orly airports to raise its main airport fees by an average of 5.5% and its ancillary airport fees by an average of 5.3% effective 1 April 2009.
- Formally, the fee proposal will be approved by the French government February 28, 2009 in order for the fee change to take effect on 1 April 2009.

The proposed fee change fits notably within the following environment:

- After taking into account the economic situation in the air transport sector, Aéroports de Paris has proposed a more moderate rate increase in 2009 than authorised by the ERA. It would maintain this fee moderation in 2010.
- The proposed changes are designed to:
  - Simplify the fee structure (lighting fees will be integrated under landing fees and the hydrant fees under aircraft parking fees).
  - Reflect, through the weighting of the various fees, the massive investment in terminals, which brings its practices in line with those of the main European airports.
- In exchange for these rate increases, Aéroports de Paris pledged to complete a €2.5 billion investment plan for its regulatory scope of business between 2006 and 2010, which is designed notably to increase the nominal accommodation capacity of its facilities by 19.4 million passengers and to improve the quality of services provided to airlines and passengers.
