

RESOLUTIONS PROPOSED TO ANNUAL SHAREHOLDERS' MEETING OF RHODIA

Paris, March 20, 2009 ----- The Board of Directors of Rhodia will submit to the Annual Shareholders' Meeting due to convene on May 20, 2009 a number of draft resolutions including one for the appointment of a new Director.

The different resolutions regarding the membership of the Board of Directors involve:

- ✓ The appointment as a Director of Mr. Patrick Buffet*, Chairman & Chief Executive Officer of Eramet.
- ✓ The renewal of the Directorships of Messrs Aldo Cardoso, Jean-Pierre Clamadieu, Pascal Colombani, Olivier Legrain and Francis Mer.
- ✓ The appointment of a Director representing employee shareholders, the Board having approved the draft resolution appointing Mr. Jacques Khéliff to this position.

If these resolutions are approved, the Board of Directors will be comprised of eleven directors including eight independent members.

Furthermore, the Shareholders Meeting will be asked to approve the agreement between Rhodia and its Chairman & Chief Executive Officer Jean-Pierre Clamadieu, implementing the provisions of the AFEP-MEDEF code of corporate governance for publicly listed companies.

^{*} *Patrick Buffet*, born on October 19, 1953, Chairman and CEO of ERAMET Group, Chairman and CEO of Le Nickel and Member of the Board of Directors of Comilog (companies within the ERAMET Group), since April 2007. He is also Member of the Board of Directors of BANIMMO (Belgium) and Member of the Supervisory Board of BUREAU VERITAS and ARCOLE INDUSTRIES. Between 2001 and April 2007, he was General Delegate, Member of the Executive Committee of Suez and Member of the Supervisory Board of Areva. Between 1998 and 2001, he held the position of Deputy General Manager, Member of the Executive Committee of Suez Lyonnaise des Eaux Group and Société Générale de Belgique.
