Thélem assurances selects "le Point XIRING V2" to accelerate the development of its health insurance business

Suresnes, May 12, 2009: XIRING, a security solutions provider for remote transactions, today announced that Thélem assurances, a French mutual insurance company, has selected the "le Point XIRING V2" service for its network of branches. The solution will provide agents with quick access to up-to-date information stored in patients' Vitale card, such as the National Health Insurance data, making it possible to draw up a health insurance contract immediately for their clients.

Launched by mid-2007, the "le Point XIRING V2" remote update service operated by XIRING helps keep the 48 million Vitale cards issued by the French Health Insurance fund up to date. An up-to-date Vitale card guarantees the validity of administrative information, patient's rights and exonerations. It also facilitates claim form management, speeds up the reimbursement process and lowers the costs resulting from errors and litigation. The "le Point XIRING V2" service is already used by more than 60% of pharmacies in France, and by many other health professionals (laboratories, medical testing centres, hospitals and clinics), providing more than 15,000 update terminals.

In order to accelerate the development of its health insurance business, Thélem assurances recently decided to equip its network of branches with "le Point XIRING V2" health card terminals. Drawing up a health insurance contract requires access to information concerning the patient's National Health Insurance centre and the rights covered. Thanks to the "le Point XIRING V2" terminal enabling the service, the insurance agent access to up-to-date information, as patients usually carry their Vitale card with them. In this way, the "le Point XIRING V2" service allows the insurer to propose and sign a contract on the spot – saving time for both the agent and the patient, who no longer needs to return to the agency with their Vitale card statement.

In addition, as of the second half of 2009, the National Health Insurance fund will gradually issue all insured persons with new generation Vitale 2 cards. These will be sent to beneficiaries, who

will then have to activate them on the National Health Insurance Network via remote update

terminals such as the "le Point XIRING V2". Thélem assurances branches will be referenced on

the National Health Insurance Fund Website.

"More than 15,000 health professionals have already chosen the "le Point XIRING V2" service to

update Vitale cards and we are proud to see that this service is now being extended to private

complementary health insurance companies. This partnership with Thélem assurances opens up

a new market for us, with significant potential for 2010-2011", commented Franck Favier, Director

of the Healthcare Business Unit at XIRING.
