Based in Bridgeport (Connecticut - USA), LSA is specialized in the design, manufacture and distribution of holographic security labels for brand protection and product authentication.

This acquisition will:

- consolidate Hologram. Industries' presence in the US market through a solid industrial and commercial base;
- provide immediate access to a second industrial platform under advantageous conditions;
- strengthen its local skill base by adding the expertise of a new team specialized in the **manufacture of security holograms**;
- further reinforce the Group's position as a provider of **brand protection solutions.**

With 30 employees, in 2010 LSA is expected to have more than US\$4 million in revenue from the sale of brand product authentication labels. LSA's customers include companies such as Motorola for which it provides security solutions for batteries and accessories. On a pro forma basis including SecureMark Decal, Hologram. Industries' US operations in 2010 would represent sales of more than US\$7 million with a balanced mix between the government sector and brand protection.

Subject to the fulfillment of the remaining conditions precedent, LSA's acquisition for an initial amount of €1.8 million would take effect on December 31, 2010 and be financed from the Company's available cash. The Sellers would also receive an earn-out payment to be based on revenue from existing business over the 2011-2015 period.
