PartnerRe Declares Dividends on Series C Cumulative Redeemable Preferred Shares and Series D Cumulative Redeemable Preferred Shares

(NYSE, Euronext: PRE) announced that its Board of Directors has declared a dividend for the period December 1, 2010 – February 28, 2011 of \$0.421875 per share on the Company's 6.75% Series C Cumulative Redeemable Preferred Shares, and \$0.40625 per share on the Company's 6.5% Series D Cumulative Redeemable Preferred Shares. The dividends will be payable on March 1, 2011, to shareholders of record on February 18, 2011.

The Company, through its wholly owned subsidiaries, also offers capital markets products that include weather and credit protection to financial, industrial and service companies. For the year ended December 31, 2009, total revenues were \$5.4 billion.
