**PEMBROKE, Bermuda, February 7, 2011** -- PartnerRe Ltd. (NYSE, Euronext: PRE) announced that its Board of Directors has declared a dividend for the period December 1, 2010 – February 28, 2011 of \$0.421875 per share on the Company's 6.75% Series C Cumulative Redeemable Preferred Shares, and \$0.40625 per share on the Company's 6.5% Series D Cumulative Redeemable Preferred Shares. The dividends will be payable on March 1, 2011, to shareholders of record on February 18, 2011.
