Pursuant to article 231-26 of the General Regulations, the AMF granted visa no. 11-173 dated 24 May 2011 on the offer document established by EDF Énergies Nouvelles in response to the simplified public cash or exchange offer initiated by EDF for the EDF Énergies Nouvelles shares.

The Offer will be opened from 27 May 2011 to 16 June 2011 included, i.e. 15 trading days.
