# VINCI creates Moroccan Facilities Management leader together with Caisse de Dépôt et de Gestion du Maroc

Through its subsidiaries CEGELEC Morocco and VINCI Facilities, VINCI has formed a partnership with Caisse de Dépôt et de Gestion du Maroc with a view to acquiring a 50% stake in Exprom, a subsidiary of CDG Développement that specializes in Facilities Management.

The acquisition of this stake will be accompanied by the sale by CEGELEC Morocco to Exprom of its multitechnical maintenance activity.

This merger, which will be submitted for approval by the competent authorities, will create Morocco's leading Facilities Management company in a steady growth, high-potential market.
