

**Turnover for the first 9 months of 2011: €12.8m  
(+11.3% on a like-for-like basis)**

**Suresnes, France, October 18, 2011: XIRING, a security solutions provider for electronic transactions, announces a turnover for the first nine months of 2011 of 12.8 million euros, up 11.3% on a like-for-like basis for the e-Health and e-ID activities.**

The turnover for the third quarter amounts to 4.0 million euros, up 12.0% compared with the third quarter of 2010 (Q3 2010 turnover was of 3.5 million euros).

**Georges Liberman, Chairman and CEO, stated:** *“XIRING continues to develop its activity, with a third quarter of growth. In the field of healthcare in France, we are seeing our first successful results from the hospital offer launched in May, which is encouraging for the development of this new segment. Moreover, the recent order placed by the French government purchases agency (UGAP) for 87,000 secure readers for the French administration confirms the growth of the e-ID market and XIRING’s potential for success on this market.”*
