- Partial exercise of the over-allotment option: amount of the offering increased to approximately €497.6 million
- Information related to stabilization

The Joint Lead Managers and Joint Bookrunners of the offering of bonds convertible into and/or exchangeable for new or existing shares (OCEANE) due January 1, 2017 (the "Bonds") launched by Technip (the "Company"), have informed the Company that they partially exercised today the overallotment option that had been granted to them.

As a result, the amount of the OCEANE offering has increased to approximately €497.6 million, representing 5,178,455 Bonds.

The issue date and settlement and delivery date for the Bonds are scheduled for December 15, 2011.

This offering is led by Barclays Capital, Citigroup Global Markets Limited, Crédit Agricole Corporate and Investment Bank, HSBC France and The Royal Bank of Scotland, the Joint Lead Managers and Joint Bookrunners. BBVA, CM-CIC, DNB Markets, Lazard-NATIXIS, SMBC Nikko are acting as Co-Lead Managers.

This press release does not constitute an offer to subscribe for the Bonds. There shall be no public offer of the Bonds in any country other than France.

In addition, Crédit Agricole Corporate and Investment Bank, acting as stabilizing manager for the purposes of the offering, pursuant to article 9 of Regulation No. 2273/2003 dated 22 December 2003 of the European Commission and article 631-10 of the Règlement général of the Autorité des marchés financiers (the "AMF"), states that:
