Vivendi places a €700 million bond

Vivendi today placed a €700 million bond with a seven-year and one month maturity and a 2.5% coupon at a price of 99.265%, corresponding to a 2.614% yield.

This operation is intended to refinance, under good market conditions, a bond with a 4.5% coupon initially issued for a seven year period, due in October 2013. It also maintains Vivendi's average debt maturity profile of above four years, at December 31, 2012.

The bond has been placed with institutional investors.
