**Mont-Saint-Guibert, Belgium, 11 July, 2013** - The biotechnology company, Cardio3 BioSciences SA (Cardio3 BioSciences), a leader in the discovery and development of regenerative, protective and reconstructive therapies for the treatment of cardiac diseases, today announces it has received a transparency declaration from Tolefi SA, Participatie Maatschappij Vlanderen (PMV) NV, Sofipole SA and Mayo Foundation for Medical Education and Research in accordance with the Belgian Law of 2<sup>nd</sup> May 2007 concerning disclosure of major holdings in issuers whose shares are admitted to trading on a Belgian regulated market.
