

## Declaration of the number of outstanding shares and voting rights as of January 31, 2015

**Vélizy-Villacoublay, France, February 6, 2015** – Dassault Systèmes (Euronext Paris: #13065, DSY.PA) reports today the total number\* of its outstanding shares and voting rights, according to articles 223-16 and 221-3 of the General Regulation of the Autorité des marchés financiers, as of January 31, 2015.

\*These numbers of shares and of voting rights take into account the 2-for-1 split of the par value effective on July 17, 2014.

\*\*The total number of voting rights is calculated on the basis of the total number of outstanding shares, even if the voting rights attached thereto are suspended, pursuant to Article 223-11 of the General Regulation of the Autorité des marchés financiers relating to the method for calculating the percentages of holdings in shares and in voting rights.
