Information on the total number of voting rights and shares of Axway Software share capital as of July 31, 2019

Paris, August 13, 2019 - In accordance with Articles L.233-8 II and R.225-73 I of the French Commercial Code (Code de Commerce) and Article 223-16 of the General Regulations of the *Autorité des Marchés Financiers* (French Financial Markets Authority), Axway Software hereby informs its shareholders that, as of July 31, 2019:

- Total number of shares is **21,225,381**.
- Total number of voting rights including suspended voting rights (gross or theoretical voting rights) is **34,757,454.** This total is the base used for declaring crossing of thresholds by shareholders (as provided for in the final paragraph of Article 223-11 of the General Regulations; the total number of voting rights is calculated according to the total number of shares with voting rights, including shares whose voting rights have been suspended).
- Number of exercisable voting rights is **34,711,895**.
