



## Publication of a transparency notification

### 1. Summary of the notification

X-FAB Silicon Foundries SE, listed on Euronext Paris, has received on August 6, 2020, a transparency notification. This transparency notification by Invesco Ltd., as the ultimate parent of Invesco Advisers, Inc. and Invesco Asset Management Limited, indicates that Invesco Advisers, Inc. and Invesco Asset Management Limited together hold 4.98% of the shares in X-FAB Silicon Foundries SE and have therefore fallen below the threshold of 5.00% of the voting rights of X-FAB Silicon Foundries SE.

This publication is made by X-FAB Silicon Foundries SE pursuant to the Belgian law of May 2, 2007, on disclosure of major holdings.
