Lysogene Secures €5 million in Non-Dilutive Financing

- Approval received from BRED for a €5 million non-dilutive financing in the form of PGE (State-Guaranteed Loan)
- Strengthened cash position with cash runway extended to Q2 2022

Paris, France — 10 February 2021 at 08:00am — Lysogene (FR0013233475 – LYS), a phase 3 gene therapy platform Company targeting central nervous system (CNS) diseases, announced today it has secured a non-dilutive financing of €5 million from BRED in the form of a state-guaranteed loan (PGE). This financing extends the Company's cash runway until Q2 2022, compared to the end of Q4 2021 previously.

This loan is 90% guaranteed by the French State with an initial maturity of 12 months and an option to amortize over 5 years.

Stéphane Durant des Aulnois, Chief Financial Officer of Lysogene stated: "This financing strengthens the Company's cash position at a crucial time in its development with the ongoing Phase 2/3 study evaluating LYS-SAF302 in Sanfilippo disease, the initiation of the clinical trial with LYS-GM101 in GM1 gangliosidosis and the development of the other preclinical programs. We would like to express our gratitude to BRED, which has been on our side since the beginning, and continues to demonstrate its confidence in the Company's development through this financing."

About Lysogene

Lysogene is a gene therapy Company focused on the treatment of orphan diseases of the central nervous system (CNS). The Company has built a unique capability to enable a safe and effective delivery of gene therapies to the CNS to treat lysosomal diseases and other genetic disorders of the CNS. A phase 2/3 clinical trial in MPS IIIA in partnership with Sarepta Therapeutics, Inc. is ongoing and a phase 1/3 clinical trial in GM1 gangliosidosis is in preparation. In accordance with the agreements signed between Lysogene and Sarepta Therapeutics, Inc., Sarepta Therapeutics, Inc. will hold exclusive commercial rights to LYS-SAF302 in the United States and markets outside Europe; and Lysogene will maintain commercial exclusivity of LYS-SAF302 in Europe. Lysogene is also collaborating with an academic partner to define the strategy of development for the treatment of Fragile X syndrome, a genetic disease related to autism. www.lysogene.com.
