A graduate of *Chimie ParisTech* and *École Nationale Supérieure du Pétrole et des Moteurs*, Emmanuelle Bromet has been appointed Sustainable Development Vice President at Arkema effective 28 July 2022.

Arkema offers cutting-edge technological solutions to meet the challenges of, among other things, new energies, access to water, recycling, urbanization and mobility, and fosters a permanent dialogue with all its stakeholders. The Group reported sales of around €9.5 billion in 2021, and operates in some 55 countries with 20,200 employees worldwide.
