



## **TRANSFER OF THE LIQUIDITY CONTRACT TO INVEST SECURITIES AND INCREASE OF THE RESOURCES ALLOCATED TO THE LIQUIDITY ACCOUNT**

**London, UK, August 31, 2023, 6:00pm CEST** – Hamilton Global Opportunities (HGO) announces that following the appointment of INVEST SECURITIES as Listing Sponsor it has also entrusted INVEST SECURITIES with the implementation of a liquidity contract relating to its ordinary shares from September 1<sup>st</sup>, 2023, until August 31<sup>st</sup>, 2024, and renewable by tacit agreement for successive one-year periods.

The contract was established in accordance with the regulations in force, and in particular AMF decision N°2021-01 of June 22, 2021. It complies with the code of ethics of the Association Française des Marchés Financiers (AMAFI).

This new contract may be suspended by either party following the completion of the first one-year period by providing the other party with two months written notice.

HGO announces also today that it increases by €60,000 (sixty thousand euros) the resources allocated to its liquidity agreement with INVEST SECURITIES.

The increase complies with the decision of the French Financial Market Authority (Autorité des marchés financiers or AMF) N°2021-01 of June 2021 establishing liquidity agreements on equity securities as an accepted market practice (the “AMF decision”).

For the record, on August 31<sup>st</sup>, 2023, the resources on the liquidity account were:

- Cash: €16,919
- Shares: 1,861

On September 1<sup>st</sup>, 2023, after this increase in the amount of cash allocated to the liquidity account, the available resources are as follow:

- Cash: €76,919
- Shares: 1,861
