Alcatel-Lucent agrees to sell its Fractional Horsepower Motors Activities to Triton

Paris, November 23, 2009 - Alcatel-Lucent (Euronext Paris and NYSE: ALU) announced today that it has agreed to sell its electrical fractional horsepower motors and drives activities, Dunkermotoren GmbH, to Triton, a leading European private equity firm which focuses on long term investments in market-leading companies based in German-speaking and Nordic countries. The agreed value of the operations ("enterprise value") is 145 million Euros. The sale is expected to close by December 31st, 2009 and the purchase price will be paid in cash.

Dunkermotoren, headquartered in Bonndorf (Germany), has operations mainly in Germany, the US, and China and is the world's largest maker of fractional horsepower drives for applications such as electric sliding doors and outdoor window shutters.

"As part of our strategic transformation Alcatel-Lucent is refocusing its operations on activities that are core to our business of providing transformational solutions and services to its service provider, enterprise, and vertical customers. Thus, we recognize that Dunkermotoren and its employees will be best positioned for further growth in a company that can leverage its broad network of activities," says Alf Henryk Wulf, Chairman of the Board of Alcatel-Lucent Deutschland AG. "Our goal was to find the right buyer, and we are very pleased that Triton recognized the value of Dunkermotoren's business and its talented people."
