France Telecom and TDC sign the final agreement to combine Orange Switzerland and Sunrise

Renens, Zurich, Paris and Copenhagen, 9 April, 2010: Following the completion of confirmatory due diligence, France Telecom and TDC signed today a final agreement to combine their respective subsidiaries in Switzerland, Orange Communication S.A. ("Orange Suisse") and Sunrise Communications S.A. ("Sunrise").

This agreement is consistent with the terms of the transaction announced on 25 November 2009 and confirms the commitment of the two groups to create a strong alternative operator in Switzerland.

The completion of this transaction is expected to occur in the second quarter of 2010, once approvals have been obtained from the Swiss competition and relevant regulatory authorities.

Gervais Pellissier, France Telecom Deputy CEO and CFO said: "I wish to underline the excellent cooperation between the TDC and France Telecom teams, which has enabled us to conclude this agreement. This merger confirms the long term commitment of France Telecom to the Swiss market to offer its clients high quality and more innovative services."

Jesper Ovesen, TDC CFO said: "This transaction creates a stronger and more efficient operator in the Swiss market. We are very pleased with our continuing cooperation with France Telecom in this market and look forward to creating further value for all stakeholders."

About TDC

TDC is the leading provider of communications solutions in Denmark with a strong Nordic focus. In the Nordic region TDC has five business units: Business, Operations & Wholesale, Consumer, Nordic and YouSee. TDC's activities outside the Nordic region primarily consist of Sunrise, a leading telecommunications provider in Switzerland. TDC was partly privatized in 1994 and fully privatized in 1998. Nordic Telephone Company ApS owns 87.9% of TDC, with the remainder of the shares held by individual and institutional shareholders.

TDC's shares are listed on NASDAQ OMX Copenhagen, its Reuters code is TDC.CO and its Bloomberg code is TDC DC.
