EXTRACT OF THE GENERAL REGULATION OF THE AMF Article 222-7

The document mentioned in the first paragraph is made available to the public at the head office of the issuer. This document is also posted to the web site of the issuer if the issuer has one. It may be included in the reference document mentioned in Article 212-13 or in the annual financial report mentioned in *a* of the 1<sup>rst</sup> paragraph of Article 221-1. When the document refers to specific information, the issuer shall indicate where such information can be obtained."
