EXTRACT OF THE GENERAL REGULATION OF THE AMF Article 222-7

It may be included in the reference document mentioned in Article 212-13 or in the annual financial report mentioned in *a* of the 1st paragraph of Article 221-1. When the document refers to specific information, the issuer shall indicate where such information can be obtained."
