

Flat sales over the first 9 months of the year Very strong growth in PLC activities, up by a factor of 3.3

HF Company Group recorded a 0.5% sales rise in the first 9 months of 2011 financial year to EUR 107.5 million. There was a slight fall in business in the 3rd quarter, when sales dropped 1.6% to EUR 34.4 million, the strong rise in PLC activities compensating for an important base effect.

PLC and Home Automation activities still doing well

- 1- The PLC segment reported three-digit growth over the quarter, spurred on by the development in operating company contracts. The new production line, which came onstream in September, should improve the competitiveness of this business.
- 2- Despite the sequential growth of over 15% in Q3 due to gains in market share in France, TV activity was badly hit by a basis "DTT" effect on international markets and a general slowdown in consumption.
- 3- Broadband activities slowed over the first 9 months of the year. Due to exchange rate differences (-9%), combined with a general wait-and-see attitude amongst manufacturers, it was not possible for Broadband activities to match the exceptional 56% rise in performance of Q3 2010.
- 4- Over the first 9 months, Home Automation activities outperformed their market, rising 11.7% compared with a fall of 6% for household electronic goods according to GFK. The very strong innovation policy pursued by the Group is the real driving force of growth in this business.

Outlook for 2011

In the expectation of faster growth at the end of the year, the HF Company Group has taken the necessary measures due to the flexibility of its model to adjust to the crisis context and is expecting a gradual improvement in its profitability in the second half.
