A - Double voting right

The introduction of a double voting right was voted by the Company's shareholders at their meeting held on 21 June 2002.

It applied with immediate effect to any fully paid-up share held in nominative form with the Company's share registrar for a minimum period of two consecutive years as allowed by article L.225-123 of the French Commercial Code.

Since then, a double voting right is automatically granted to each fully paid-up share which meets the criteria set in the abovementioned article of the French Commercial Code.
