Altran and Launch Automotive Design Co., Ltd. set up a jointventure in China: Altran Automotive Technology (Shanghai)

Altran, a European company, global leader in innovation and high-tech engineering consulting, and Launch Automotive Design, one of China's leading automotive design provider, set up a joint-venture (JV) in China, in the field of Automotive Mechanical & Digital Engineering: Altran Automotive Technology (Shanghai) Co. Ltd.

Altran will own 51% while Launch Automotive Design 49% of this joint-venture.

With an annual production and sales volume of over 20 million cars at present, China ranks the first in the world. China is a key market for Altran in Asia, where the Group is pursuing development in line with the strategic plan 2012–2015 launched in 2011 by Philippe Salle, Chairman and Chief Executive of the Altran group. Altran has already created in 2013 its first JV Altran–Beyondsoft (Beijing) Technologies addressing the Intelligent Systems for Telecom and Automotive industries.

The creation of this second JV finds its origin in increasing localisation of Product Design & Engineering in the Automotive industry in China, benefiting from Launch Automotive Design centers relevantly located in 6 cities (Shanghai, Chongqing, Tianjin, Nanchang, Changshu and Baoding). Chinese consumers are requesting more and more "designed by Chinese for Chinese" with new cars meeting local requirements, especially for what is related to the body in white, the chassis, interior/exterior, both from quality and functionality standpoint. With Altran Automotive Technology, Altran and Launch will then develop high end engineering services, based on the perfect combination of the automotive design expertise from Launch and technical program management from Altran.

With Altran Automotive Technology (Shanghai), we will be a major player implementing this full localisation strategy, realizing the "Chinese for Chinese" design services of tomorrow. That is key in our market – whilst remaining consistent with the practices and standards of 30-year of experience of our Group, the global leader in innovation and high-tech engineering consulting."
