

EDF GROUP ACQUIRES PETROBRAS' 10% REMAINING STAKE IN USINA TERMOELÉTRICA NORTE FLUMINENSE S.A

Paris, 12 April 2014. EDF Group¹, has completed yesterday the acquisition of the 10% remaining stake owned by Petróleo Brasileiro S.A. (Petrobras) in Usina Termoeletrica Norte Fluminense S.A. (NTF) and now has full ownership of the Company. There are no pending approvals from Brazilian Antitrust Authorities or by the Brazilian Electricity Regulatory Agency (ANEEL).

Petrobras will continue to supply gas to NTF and will keep its longstanding partnership with EDF in Brazil and the rest of the world.

This transaction is in line with EDF's ambition to reinforce its presence in assets and countries where it can fully deploy its industrial strategy.

Usina Termoeletrica Norte Fluminense is a combined cycle, gas fired power plant located in Macaé, state of Rio de Janeiro. The company has a 20-year Power Purchase Agreement with Light Serviços de Eletricidade S.A. and a 20-year Gas Supply Agreement with Petróleo Brasileiro S.A. and CEG Rio S.A.

About Petróleo Brasileiro S.A.

Petróleo Brasileiro or Petrobras is a publicly traded corporation, the majority stockholder of which is the Government of Brazil. It is a multinational energy corporation operating in 28 countries with headquarters in Rio de Janeiro, Brazil.

Petrobras is partner with EDF Group, through Edison S.p.A., on Ibiritermo S.A., a 226 MW thermoelectric plant in the municipality of Ibirité in Minas Gerais.

EDF Group, one of the leaders in the European energy market, is an integrated energy company active in all areas of the business: generation, transmission, distribution, energy supply and trading. The Group is the leading electricity producer in Europe. In France, it has mainly nuclear and hydropower generation facilities where 95.9% of the electricity output is CO2-free. EDF's transmission and distribution subsidiaries in France operate 1,285,000 km of low and medium voltage overhead and underground electricity lines and around 100,000 km of high and very high voltage networks. The Group is involved in supplying energy and services to approximately 28.5 million customers in France. The Group generated consolidated sales of €75.6 billion in 2013, of which 46.8% outside of France. EDF is listed on the Paris Stock Exchange and is a member of the CAC 40 index.
