

Alcatel-Lucent announces the results of its tender offer process

Company accepts notes for purchase on the terms set out in the Tender Offer Memorandum dated June 24, 2014

Paris, France, July 3, 2014 - Alcatel-Lucent (Euronext Paris and NYSE: ALU) has announced today that it has decided to accept for purchase an aggregate nominal amount of Notes of Eur 210,391,000.

Capitalised terms used in this announcement, but not defined, have the meanings assigned to them in the Tender Offer Memorandum dated June 24, 2014.

As at the Expiration Deadline of 17:00 CET on July 2, 2014, an aggregate nominal amount of Eur 210,391,000 of Notes had been validly tendered in the Offer. The outstanding aggregate nominal amount of Notes following settlement of the Offer and cancellation of the Notes tendered in the Offer will be Eur 194,966,000.

Alcatel-Lucent has decided to accept for purchase all Notes that have been validly tendered.
