Cegid has signed an agreement in principle to acquire the US company JDS Solutions Corporation (www.jdssc.com), a provider and distributor of IT solutions for specialized retailers.

The transaction is expected to be finalized in May, subject to a certain number of conditions precedent.

Founded in 2000 and based in San Diego, CA, JDS Solutions is a longstanding provider of software to specialized retailers.
