About Ramsay Santé:

Formed in 2005, Ramsay Santé is now a public limited company (société anonyme) with a board of directors and a share capital of €72,260,652 registered in the Paris Trade and Companies Register under number 484 349 360. Ramsay Santé's registered office is located at 53, avenue Victor Hugo, 75116 Paris.

Ramsay Santé is a private healthcare provider. It is now the third-largest French hospital group in terms of the number of its facilities. Ramsay Santé operates a total of 40 facilities which are active in two main sectors:

- *MSO Business (Medicine, Surgery and Obstetrics): 11 clinics offer a range of care in medicine, surgery, obstetrics, cancer and haemodialysis, 8 of which are in the Paris region, one in the Bourg-en-Bresse area and two in the Toulouse area. These clinics provide treatment which requires short-term stays.*
- *Mental Health, Addiction Treatment and ACR (After Care and Rehabilitation): 29 facilities offer healthcare services in the fields of psychiatry, mental health and addiction treatment, where patients are treated mostly during medium and long-term stays.*
