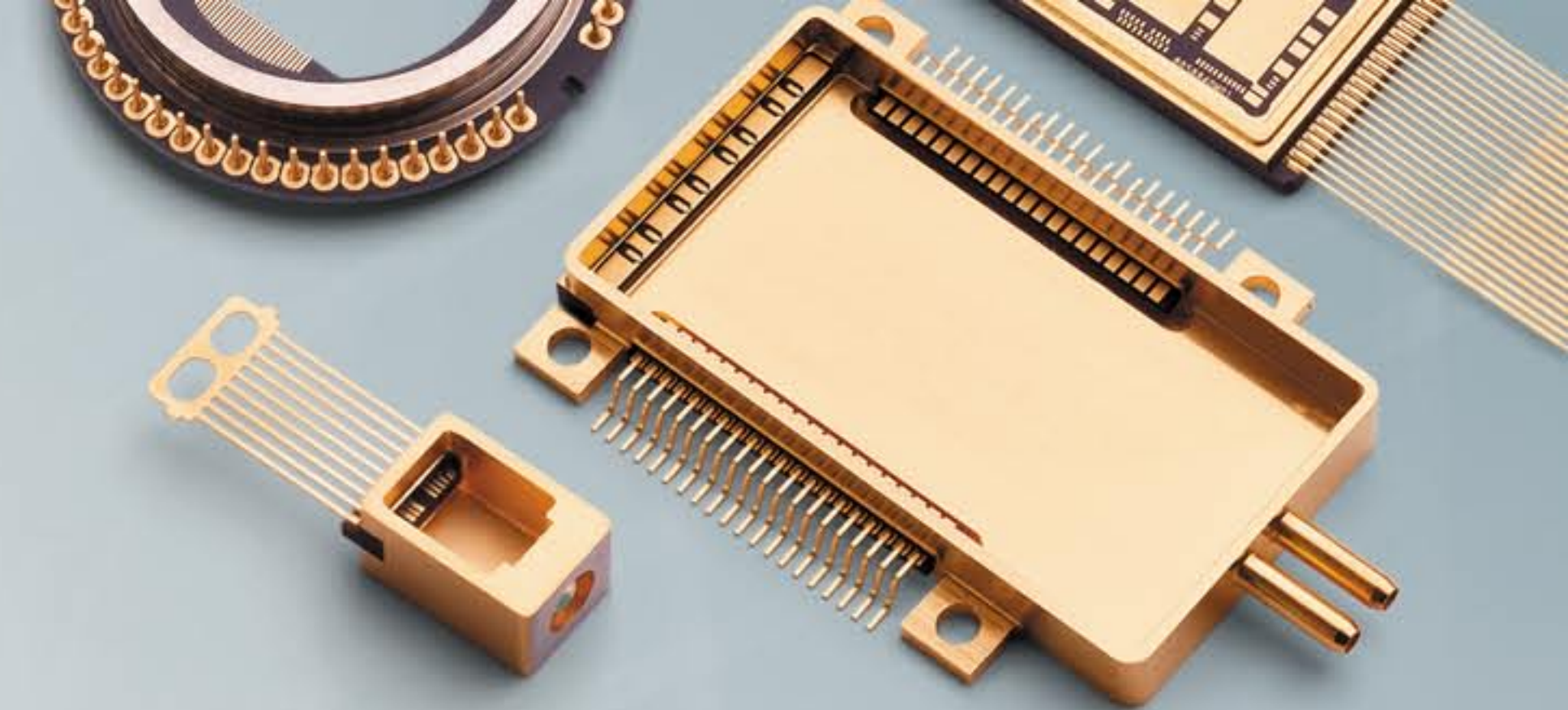




EGIDE SIGNS A LONG-TERM AGREEMENT WITH SOFRADIR
