## Acquisition of Roff: Gfi Informatique gains strength in SAP solutions

With the acquisition of Efron, a Spanish IT company, which was announced last week, this transaction doubles Gfi's revenues in Iberia to more than 200 M€ and simultaneously opens the doors to the Americas, with more than 12 M€ in sales to Brazil, Mexico, and Colombia. Those two operations should also contribute to the improvement of Iberia profitability.
