

Filing of the Vallourec 2016 Registration Document including the 2016 Annual Financial Report

Boulogne-Billancourt (France), 21 March 2017 – Vallourec, world leader in premium tubular solutions, today announces the filing of its 2016 Registration Document, including the Annual Financial Report for the 2016 fiscal year, with the French securities regulator, the *Autorité des marchés financiers* (AMF) on 21 March 2017 under the number n° D.17-0191.

- a description of Vallourec 's share buyback program in accordance with Article 241-2 of the AMF Regulations.
