

COMBINED SHAREHOLDERS' MEETING OF MAY 16, 2017

Neuilly-sur-Seine, France, March 31, 2017 – Bureau Veritas (the "**Company**") hereby inform its shareholders that its combined general meeting (ordinary and extraordinary) (the "**Meeting**") will be held on Tuesday May 16, 2017 at 3:00 p.m. at Pavillon Gabriel, 5 avenue Gabriel, 75008 Paris.

The preliminary notice of meeting (*Avis de réunion*), including in particular the agenda of the Meeting and the draft resolutions proposed by the Board of Directors and which will be submitted to the Meeting, has been published today in the legal gazette "*Bulletin des Annonces Légales et Obligatoires*" n°39 (<u>http://www.journal-officiel.gouv.fr/balo/</u>) and on the Company's website (<u>www.bureauveritas.com</u>).

The documents and information referred to in Article R.225-73-1 of the French Commercial Code will be available on the Company's website (<u>www.bureauveritas.com</u>) under Shareholders / Shareholders Meeting, at the latest on the twenty-first day before the Meeting (i.e. at the latest on **Tuesday April 25, 2017**).

All other preparatory documents pertaining to the Meeting will be available to the shareholders at the Company's registered office and/or on the Company's website (<u>www.bureauveritas.com</u>), under Shareholders / Shareholders Meeting, in accordance with applicable legal and regulatory provisions, at the latest as from the publication of the notice of meeting (*Avis de convocation*) in the legal gazette *"Bulletin des Annonces Légales et Obligatoires"*.

Shareholders may also request, as from the publication of the notice of meeting (*Avis de convocation*) in the legal gazette "*Bulletin des Annonces Légales et Obligatoires*" until the fifth day (included) prior to the Meeting, i.e. until **Thursday May 11, 2017 (included)**, that the documents and information referred to in Articles R.225-81 and R.225-83 of the French Commercial Code be sent to them in accordance with the following:

- <u>for shareholders whose shares are held in registered form</u>: to BNP Paribas Securities Services – Service Assemblées Générales – CTS Assemblées Générales – Les Grands Moulins de Pantin, 9 rue du Débarcadère, 93761 Pantin cedex, France;
- for shareholders holding bearer shares: either to the financial agent who manages their shares, or, provided they attach to their request an ownership certificate issued by their financial agent, directly to BNP Paribas Securities Services at the address above.
