- for shareholders holding registered shares: to BNP Paribas Securities Services Service Assemblées Générales CTO Assemblées Générales Grands Moulins de Pantin, 9 rue du Débarcadère, 93761 Pantin cedex (France); and
- <u>for shareholders holding bearer shares</u>: either to the authorized financial intermediary who manages their shares, or, provided they attach to their request an ownership certificate issued by their authorized financial intermediary, directly to BNP Paribas Securities Services at the address above.
