The increase in rental income is principally based on taking into account, over 9 full months in 2008, contributions and acquisitions that took place during the 2nd half of 2007, as follows:

- ➤ The consolidation of SCI Percier UIS 062 St Quentin Fallavier on June 15 2007 (impact: €522,000 on logistics activity)
- The consolidation of assets following the contributions made by Foncière des Régions and Sophia GE on 24 July 2007 (impact: €17,696,000 on logistics activity and €5,988,000 on light industrial)
- ➤ The consolidation of companies following the contributions made by Foncière des Régions on 24 July 2007 (impact: €2,052,000 on logistics activity and €4,401,000 on light industrial)
- The acquisition of the Garonor companies on 31 July 2007 (impact: €6,184,000 on logistics activity and €9,590,000 on the Garonor-Aulnay site)

➤ The consolidation of assets following the contributions made by Morgan Stanley on 22 November (impact: €10,389,000 on logistics activity, of which €1,697,000 in France).

For the record, the company Foncière Europe Logistique did not have any turnover during the 1st quarter of 2007, due to the change of activity undertaken:

- Disposal of historic surge protection industrial activity in the framework of a partial transfer of assets on 16 May 2007, retroactive to 2 January 2007;
- New orientation towards the rental of buildings for logistics in mid-June 2007.

Significant events for the third quarter

During the 3rd quarter of 2008, Foncière Europe Logistique continued its three development operations begun in 2007 in Bollene (30,000 m²), Corbas (15,000 m²) and Chalon sur Saône (11,500 m²) as part of its client development strategy.

These three operations will be completed in the fourth quarter of 2008.
