ATTI joins the TR SERVICES Group as of 31 March 2009

Paris, 1 April 2009

Following the preliminary announcement on 10 March 2009 of an agreement concerning the link-up between Télécom Réseaux Services and ATTI (Assistance Technique Telecom Informatique), Télécom Réseaux Services acquired the control of ATTI from the latter's shareholders under an agreement signed on 31 March 2009.

This has resulted in Télécom Réseaux Services acquiring 2,946 of the 5,889 shares making up ATTI's share capital. A firm commitment concerning the acquisition of the remaining shares is also part of the agreement.

This acquisition will enable the TR Services Group to implement its strategic development plan. The Group has set itself two main initial targets: to enhance its operating presence in France and to further develop its technological expertise.

ATTI is a strategic partner of Aastra in France as a certified "Gold Partner" and "Technical Assistance Centre". A renowned service provider, ATTI has operations in Bordeaux, Lille, Lyon, Nantes, Narbonne and Paris.

At the end of December 2008, ATTI's unaudited equity stood at over €500,000 with net cash of over €600,000.

As the acquisition took place on 31 March 2009, it will not impact the TR Services Group's published earnings for the financial year ended on the same date. However, the effects of this change in the scope of consolidation will be reflected in the Group's consolidated balance sheet and cash flow statement as at 31 March.

Commenting on the acquisition, Lionel SMEERS, Chief Executive Officer of the TR Services Group, states: "With ATTI, the TR Services Group is making an acquisition that fits in fully with its strategy by integrating an added-value service provider with a high level of expertise in Aastra solutions and a healthy balance sheet. This move will enable us to target over 90% of the French market with the highest possible level of technological expertise and should enable us to generate sales of €50 million within a short space of time".
